## SARTHI Scholarship Scheme

- DJMIT has launched its ambitious scheme of SARTHI on 15/8/20. Under the scheme initially, Rs. 15,000/ per student as "Sarthi DJMIT Scholarship for 50 students of 12<sup>fth</sup> students of Anand Distt will be approved on Entrance Exam merit basis. The no. of scholarships may be increased in due course of time if need arise. 25% reservation will be there for SC/ST students. The scheme will be gradually introduced for std 10<sup>th</sup>/11<sup>th</sup> also in due course of time and also in Kheda distt, if found feasible.
- Respective Principal of Schools will have to recommend to DJMIT for awarding Scholarship to the eligible student and compliance of Memorandum of Agreement (herein after referred as MOA) as well fulfillment of student's obligations under the MOA and shall have to take responsibility reg compliance have to submit bond of such amount as prescribed from time to time while accepting the scholarship along with MOA.
- DJMIT shall mean and referred to Dr Jivraj Mehta Institute Of Technology, Mogar, Anand and shall include its management or competent authority in behalf of this Sarthi scheme or any authorized signatory on behalf of DJMIT. Such students who have been approved and availed SARTHI scholarship will be designated as "Sarthi Scholar" Or "Student". CENT shall mean Charuttar Education and "Yojna"
- Selection Process Entrance exam will be conducted by DJMIT every May/June or at such date as may be decided by DJMIT
- 5. Benefits/ comforts to SARTHI Scholars-
- A) Awarding Sarthi DJMIT Scholarship of Rs. 15,000 for 12<sup>fth</sup> students on Entrance Exam merit basis, in 2 installments in time frame as decided by DJMIT subject to he/she shall pass the HSC 12<sup>fth</sup> std. board examination
- B) Prospective Job/ placement or recommendation for starting with internship on pan India level will be assured after successful completion of degree prg at DJMIT subject to such terms and conditions offered by placement / service offering company/ firm and also to such terms / regulations as may be laid down by DJMIT from time to time like attendance , performance with desired CPI , conduct, participation in DJMIT sponsored programs / projects, personality development inputs , successful completion of internship and any such items affecting placement and job offer.
- C) DJMIT will arrange practice sessions/ mock exams for 11/12 std students to prepare them for the final exams . Free coaching / Tuition classes will be made available in selected topics / subjects for 12 std students at DJMIT during vacation / week ends as per connivence of faculties
- D) Only 25% Tuition fees shall be paid by Sarthi scholars as decided by FRC from time to time . <u>However if Student fails any semester, then in such case 40% tuition fee of that semester will have to be paid by concerned student till he/she clears for next sem. Again he will come in 25% slab . 75% Tuition fees will be waived from Sarthi Scholars for General categories. So in other words , SARTHI Scholars will be awarded Scholarship of Rs. 1.8 lakhs Tuition fees for 4 years to gather (at base of Rs 60,000/ per year for current Fee Fixation Year Block by FRC ) by DJMIT.</u>

- E) Special scholarship of Rs 15,000/ shall be awarded to all SC/ST students taking the Sarthi scholarship during their 4 years of study at DJMIT to make them self-reliant, subject to passing out from respective academic year and student shall be eligible to receive scholarship or fee ship card benefit. NO tuition fees will be payable by SC/ST students however, in case of Sarthi Scholar from SC/ST categories and is eligible for any scholarship from Govt or any other agency or having fee ship card, the same tuition fee or scholarship receivable from government shall be retained by DJMIT. SC/ST students will be given 50% fee waiver in Hostel fees.
- F) In addition to Sarthi Scholarship , DJMIT may try to get financial benefits from community organizations/ industry or NRI etc for sponsorships of students to make them more self-reliant.
- G) DJMIT will give priority and preference in projects works , internships to Sarthi Scholars.
- H) DJMIT may guide and support scholars to go for higher studies to USA / Canada and extend all help as may be possible
- DJMIT will extend all possible help and guidance for Startup of business and Incubation activities for such Sarthi Scholars who desire to start their own business.
- J) DJMIT will extend all possible help to Scholars for proficiency in English Language guidance and Personality development skills
- 6. Obligations under Sarthi Scholarship Agreement
  - 1) Tripartite MoA will be signed between <u>student &</u>student's Parents/ Guardian <u>as First party</u>, <u>School</u> <u>Principal/management</u> and DJMIT <u>as second party and School Principal/management</u> as confirming party (Third party)
  - 2) Once MoA signed, student shall have to continue in the scheme as per terms of agreement. Students availing the Sarthi Scheme Scholarship shall have to give bond securitySurety of equal to approved scholarship /, guaranteed by school management. PRC will recommend to DJMIT further course of action in such cases of student willing to discontinue subject to of securitySuretybond terms. In case, student fails in 12 <sup>fth</sup> HSC board examination, he/shall return the scholarship immediately.
  - 3) It will be mandatory for SARTHI Scholars to seek, confirm and enroll FYBE admission in any branch of his/her choice in DJMIT <u>. Student shall give 3 preference of his choice of branches available in</u> <u>DJMIT and DJMIT shall ensure student is confirmed admission and enrolled in any one of his/her</u> <u>choice based on first come</u>, firsts serve basis. with Sarthi Scholars.
  - 4) The Sarthi Scholars will have to enroll / fill choice for admission to FYBE at DJMIT admission help desk and complete admission process from DJMIT only with DJMIT as his/her first choice with any 3 branches of his/her choice in DJMIT. DJMIT shall ensure the Student is confirmed his/her admission in any one of his 3 choices on first come first serve basis. -
  - 5) Scholarships received from any govt deptt/ under govt scheme shall be retained by DJMIT in case of SC/ST students. In case of SC/ST student becoming not eligible to receive scholarship or fee ship card benefits , he/she shall have to pay 25% of tuition fees as general category till he receives such scholarship / fee ship benefit in next year
  - 6) Any regulatory frame work mandated by any regulatory authority shall be binding to SARTHI students availing this scholarship. In case of any provision of this Sarthi schemes is ambiguous or contrary to the provisions of any govt authority statutes ,mandates directions or regulations , the same will be applicable to the Sarthi Scholars and the Sarthi scheme and necessary changes will be effected by DJMIT, SARTHI Scholar will have to agree to such changes .
  - 7) STUDENT shall agree that he/ shall request in writing to Institute, only after repaying/ returning scholarship amount of Rs 15,000/ or whatever the amount approved under scheme, for No Objection certificate (NOC) if he/she desire to exit from scheme and to seek/apply, confirm and or enroll for admission in any course in any other college approved by AICTE or any other institute approved by competent authority in India. DJMIT will issue such NOC only after receiving the returned amount of scholarship from concerned student. In other words the STUDENT / Sarthi scholar shall not, without having given prior intimation to Institute and obtained NOC from DJMIT, apply or seek or confirm or Enrol admission in first year in any other college, approved by AICTE or any other institute approved by competent authority in India.

- 7. Except Amount of Scholarship as decided from time to time, all other benefits / comforts listed at para 5 above are extended help, support and comforts to be made available to the extent possible for making the Sarthi Scholars self-reliant, successful to have better career and shall not be considered or construed as "Rights" or "claims". Further it is provided that such benefits / comforts shall not be construed "obligations" or Responsibilities" or compulsions on part of CENT or DJMIT and the same shall not be claimed or shall not be treated to get them enforced by any SARTHI Scholar through any *quasi*legal forum or competent court of law.
- 8. DJMIT may change any terms / conditions of the schemes from time to time in interest of students or DJMIT or both as the case may be .However once MoA signed , the same will not be changed by either DJMIT or respective student / parties except warranted or required by any govt authority for compliance of any of its mandate. In case of any dispute between DJMIT and student regarding discontinuance , two member team , one each nominated by DJMIT management and School management shall decide the dispute , to be ratified by PRC and same shall be final . No legal proceedings can be initiated by either party against the said resolution of dispute .
- 9. Apply and Registration Interested students shall apply to <u>diradmin@centanand.org</u> in prescribed format available on <u>www.djmit.ac.in</u> thorough school Principal on or before 31/12/20. Date of entrance exam will be notified separately if required.
