(hereinafter refereed as DIMIT or Institute ), Vill- Mogar, Dist.- Anand - 388410, GUJARAT, INDIA managed by Charuttar Education and Navrachana Trust (hereinafter refereed as hereinafter referred as CENT), an Institute approved by AICTE and having its office at DJMIT College campus, NH-8, Vill - Mogar, Dist.- Anand - 388410, GUJARAT, INDIA hereinafter referred to as "institute" as the FIRST Part

## AND

Mr.(hereinafter referred to as "Sarthi Scholar or Student through his/her parents or legal Guardian and also be as Student Surety) of the SECOND Part

AND

The xxxx (school Name of the Sarthi Scholar Student ) has agreed to recommend and confirm this Memorandum of Agreement as confirming party or Third party ,

WHEREAS the Institute has approved SARTHI scheme vide it is office order No xxx dated xxx and under the SARTHI Scheme ,SARTHI SCHOLAR (hereinafter referred as Student ) who hereinafter appearing as Student and has consented and agreed to furnish a surety to fulfilment of the obligations on his part under this MoAand the Student surety has given his consent to the same.

NOW IT IS AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. Definitions
  - a) SARTHI- xxxx , Scholarship scheme notified by DJMIT office order No xxx dat xx xx and implemented by DJMIT or CENT under and subject to compliance of any/all terms and conditions therein . Hereinafter refereed as Scheme or Yojna or Sarthi
  - b) SARTHI SCHOLAR or STUDENT- Student who has been approved for receiving Sarthi scholarship under the scheme , subject to terms and conditions of the scheme also refereed as student
  - c) Scholarship-Scholarship as approved under the Sarthi scheme by DJMIT
- 2. Approval of Scholarship- DJMIT has approved Scholarship under its Sarthi Scheme subject to terms and conditions mentioned in the scheme vide its approval order date- xxx
- 3. Consent of Student to furnish Surety The student and his /herparents/guardian have consented / agreed to abide by terms and conditions of the Sarthi Scheme and have consented and agreed to furnish a surety to fulfilment of the obligations on their part under this MoA and consequent to the Student Surety has furnished surety in form of irrevocable bond for the amount equal to approved scholarship
- 4. Consent to agree to obligations of the scheme The student Surety hereby undertake, agree and gives consent for his/her binding towards all obligations, especially para6(six) of the scheme.



- 5. This is hereby agreed upon that the STUDENT shall seek , confirm and enroll admission in FYBE in Academic Year 20xx-xx in DJMIT as per terms and conditions and in compliance of the same , as mentioned in the Sarthi Scholarship Scheme after receiving scholarship Of Rs 15,000/.
- 6. This is hereby agreed upon that the INSTITUTE will disburse the amount of scholarship as per provisions and terms of the Sarthi Scheme
- 7. This is hereby agreed upon by the Student that he/she shall be obliged to fulfil and comply all the responsibilities on his/her part asper the office order of Sarthi scheme dated xxx as amended from time to time. Furthermore, the student undertakes to furnish Security Bond of Rs 15,000/ in favour of DJMIT in token of such binding to the instituteas and when requisitioned or deem necessary by Institute.
- 8. This is hereby agreed upon by STUDENT that he/ shall request in writing to Institute , only after repaying/ returning scholarship amount of Rs 15,000/ or whatever the amount approved under scheme , for No Objection certificate (NOC) if he/she desire to exit from scheme and to seek/apply, confirm and or enrol in any other college approved by AICTE or any other institute approved by any competent authority in India . DJMIT will issue such NOC only after receiving the returned amount of scholarship from concerned student. In other words the STUDENT / Sarthi scholar shall not, without having given prior intimation to Institute and obtained NOC from DJMIT , apply or seek or confirm or Enrol admission in any course in any other college , approved by AICTE or any other institute approved by any competent of the stitute approved by any course in any other college , approved by AICTE or any other institute approved by any confirm of the stitute approved by any course in any other college .
- 9. It is further agreed upon by the Student that in case of his/her non-compliance of any of the obligations , particularly to seek , confirm and enroll admission in FYBE in DJMIT as per terms and conditions of the Sarthi scheme shall make DJMIT enable, eligible and entitledto encash the amount of Surety bond given for the student .It is further provided that in case of student's failure to seek , confirm and enrol in FYBE at DJMIT , the management of school shall arrange or shall cause to arrange recovery of the surety amount or to be encashed as guaranteed as confirming party by all available administrative and /or legal ways and means to them with due process and shall help/support DJMIT in recovering the scholarship amount .
